- Online Request: Go to www.irs.gov, under "Get your Tax Record"
- Select "Get Transcript Online" or "Get Transcript by Mail"
- Be sure to request a 2019 Tax Return Transcript

To Link your IRS Tax Return to the FAFSA "IRS Data Retrieval Tool"

- Login to your 2021-2022 FAFSA https://studentaid.ed.gov/sa/fafsa
- Select the 2021-2022 FAFSA
- Click "Make FAFSA Corrections" and create a Save Key
- Select "Making corrections to a processed FAFSA" and select "Next"
- Select the "Financial Information" tab
- If eligible, the "Link to the IRS" box will appear under the Student Financial and Parent Financial sections
- On IRS page, enter information exactly as it appears on tax return and click "Submit"
- If you use the IRS DRT to transfer your tax return information from the IRS, the information will not display on your FAFSA
- Be sure to continue to the "Sign and Submit" tab to enter Student and Parent FSA ID and submit the FAFSA corrections.

Individuals Granted a Filing Extension by the IRS

An individual, who is required to file a 2019 IRS income tax return and has been granted a filing extension by the IRS, must provide:

- A copy of the IRS Form 4868, "Application for Automatic Extension of Time to File U.S. Individual Income Tax Return," that was filed with the IRS for tax year 2019;
- A copy of the IRS's approval of an extension beyond the automatic six-month extension if the individual requested an additional extension of the filing time for tax year 2019;
- Verification of Non-filing Letter (confirmation that the tax return has not yet been filed) from the IRS or other relevant tax authority date on or after October 1, 2020;
- A copy of IRS Form W-2 for each source of employment income received for tax year 2019, and,
- If self-employed, a signed statement certifying the amount of the individual's Adjusted Gross Income (AGI) and the

U.S. income tax paid for tax year 2019.

Individuals Who Filed an Amended IRS Income Tax Return

An individual who filed an amended IRS income tax return for tax year 2019 must provide:

- A **2019 Tax Return Transcript** (that will only include information from the original tax return and does not have to be signed), or any other IRS tax transcript(s) that includes all of the income and tax information required to be verified; **and**
- A signed copy of the 2019 IRS Form 1040X, "Amended U.S. Individual Income Tax Return," that was filed with the IRS

Individuals Who Were Victims of IRS Tax-Related Identity Theft

An individual who was the victim of IRS tax-related identity theft must provide:

- A Tax Return Data Base View (TRDBV) transcript obtained from the IRS, or any other IRS tax transcript(s) that includes all of the income and tax information required to be verified; **and**
- A statement signed and dated by the tax filer indicating that he or she was a victim of IRS tax-related identity theft and that the IRS is aware of the tax-related identity theft.

Individuals Who Filed Non-IRS Tax Returns

- A tax filer who filed an income tax return with Guam, the Commonwealth of the Northern Mariana Islands, Puerto Rico, the U.S. Virgin Islands, or a foreign country may provide a signed copy of his or her income tax return that was filed with the relevant tax authority. A tax filer, who filed with the tax authority for American Samoa, must provide a copy of his or her tax account information.
- If a foreign return was filed, convert all monetary units to US dollars using the exchange rate that is in effect today.
